Development Conference 2021 (WTDC-21)

Dear Madam/Sir,

I refer to the consultation of Council Member States carried out by letter <u>DM-21/1010</u> of 15 April 2021 relating to the change of dates of the next World Telecommunication Development Conference (WTDC-21) originally scheduled for 8 to 19 November 2021 in Addis Ababa, Federal Democratic Republic of Ethiopia. I am pleased to inform you that the Council Member States have supported changing the dates for the next WTDC to 6 to 15 June 2022, as proposed by the Government of Ethiopia. I also fully take note of the concerns expressed by Member States to have enough time to take a decision.

Pursuant to No. 46 of the ITU Convention, all Member States of ITU having the right to vote are thus invited to inform the Secretary-General of their concurrence with the change of dates of WDTC-21 as described above, by using the new <u>online tool</u>*, or using the template in <u>Annex 1</u> by e-mail to <u>memberstates@itu.int</u>, **not later than 22 June 2021**. The Secretariat remains at your disposal if needed.

If your country has already responded to the first consultation sent via <u>DM-21/1010</u> to Council Member States, your reply to the first consultation will also be considered as valid with regard to this consultation of all Member States, unless otherwise notified by the Councillor or the Administration Focal Point in writing by e-mail to <u>memberstates@itu.int</u>.
