Coordination for Asia-Pacific (RRS-15-Asia-Pacific)

Manila, Philippines, 25-30 May 2015

Dear Madam, Sir,

I am pleased to inform you that, at the kind invitation of the <u>Information and Communications Technology</u> <u>Office, Department of Science and Technology</u> (ICTO-DOST) of the Philippines, the International Telecommunication Union (ITU) organizes the Regional Radiocommunication Seminar 2015 and Workshop on Satellite Coordination for Asia-Pacific (RRS-15-Asia-Pacific), in cooperation with the <u>Asia-Pacific Telecommunity</u> (APT), and the <u>Department of Communications, Government of Australia</u>, to be held in Manila, Philippines, from 25 to 30 May 2015.

RRS-15-Asia-Pacific will be held in the following format (see the Annex: Proposed Programme):

- A pre-event web tutorial will be available on the ITU website: www.itu.int/go/ITU-R/RRS-15-Asia-Pacific/webtutorial, with the basic concepts of spectrum management at national and international levels, their links with ITU Radio Regulations (RR), ITU and ITU-R structures and functions, including the study groups and BR departments, and ITU basic texts, with the main focus on RR and their associated Rules of Procedure (RoP). A good understanding of the pre-seminar web tutorial concepts is required in order to be able to participate actively in the seminar.
- The first two days of the event will cover concepts related to spectrum management as well as the procedures associated to the recording of frequency assignments in the Master International Frequency Register (MIFR). The review of the modifications to the RR, associated WRC Resolutions and ITU-R Resolutions decided by the last World Radio Conference (WRC-12) and Radiocommunication Assembly (RA-12) as well as agendas of the next WRC-15 will follow. These two days will also cover the current regulatory framework for international frequency management and the ITU-R Recommendations and best practices regarding the use of spectrum for both

terrestrial and space services, including basic training on ICT tools developed by ITU for frequency notifications for those services and for the technical examinations.

- The 3rd day will be devoted to a Workshop on Terrestrial Services.
- The 4th and 5th days will be dedicated to a Regional Workshop on Satellite Coordination. These two regional workshops will enable the participants to get hands-on experience with ITU notification procedures as well as with the software and electronic publications made available by the Radiocommunication Bureau to the Administrations of Member States and to the ITU Sector Members, with emphasis in space services but also including terrestrial ones.
- RRS-15-Asia will conclude with a Forum on Saturday 30th May 2015, on "Space Planned Services: current status and challenges", with participation of regulators, operators, space manufactures, ground platforms manufactures, satellite-based ISP, providing a multidisciplinary approach: regulatory, commercial and technical, about the present and the future of these services in the region.

Languages

The lectures and discussions during RRS-15-Asia-Pacific will be in English.

Format

The RRS-15-Asia-Pacific will be conducted in a "paperless" environment, i.e. the seminar and workshops documentation will be available on the website. Given the amount of practical work expected during the workshops, participants are required to bring their laptops, performing the set of minimal specifications detailed on the ITU website: www.itu.int/go/ITU-R/RRS-15-Asia-Pacific/laptop-requirements.

Registration

Member States, ITU Academia, ITU-R Sector Members and Associates, ITU-D Sector Members and Associates, from Asia-Pacific countries are invited to attend the RRS-15-Asia-Pacific. Attendance to this event is free of charge for their representatives.

Registration for this event is carried out exclusively online, through respective ITU-R designated focal point (DFP). The lists of DFPs for ITU-R activities¹ is available at www.itu.int/en/ITU-R/information/events. Participants are invited to contact their DFP to be registered to this event. Advance registration of all participants is strongly advised. Unannounced participants might face further delays at the on-site registration desk.
