The WCIT-12 Secretariat is pleased to present the WCIT Proposals Management System (PMS) which has been developed to assist you with tracking proposals received for the work of the World Telecommunication Standardization Assembly (WTSA-12) and the World Conference on International Telecommunications (WCIT-12).

## 1) Proposal index

In accordance with the provisions of No. 42 of the General Rules of Conferences, Assemblies and Meetings of the Union, the secretariat will annotate proposals with index numbers.

Each proposal will carry a sequential number to identify the provision to which the proposal is related. The index number will be composed as follows:



- ACTION: Will be proposed as follows:

Actions

Code	Description
ADD	Proposal to add new text to the ITRs NOTE – Where new text is to be added within an existing paragraph or sub-paragraph, the symbol MOD should be used (see instructions for MOD below).
ADD*	Proposal to add existing text from elsewhere in the ITRs NOTE – It is necessary to reproduce the texts carrying the symbol ADD*.
MOD	Proposal to amend ITRs text by addition, deletion or replacement of words or figures NOTE – To amend the text, turn on track changes, make modifications (deleted text should then appear as crossed out, and added texts should then appear as underlined).
(MOD)	Proposal to amend ITRs text, from an editorial point of view
SUP	Proposal to delete ITRs text / ITRs provision(s), Resolution(s), Recommendation(s) or Opinion NOTE 1 – It is not necessary to reproduce texts carrying the symbol SUP. NOTE 2 – Where text is to be deleted from within a paragraph or sub-paragraph, the symbol MOD should be used (see instructions for MOD above).
SUP*	Proposal to transfer text elsewhere in the ITRs NOTE – It is not necessary to reproduce texts carrying the symbol SUP*.
NOC	ITRs text for which no change is proposed NOTE – This symbol may be used to clarify that no proposals are made with respect to texts carrying this symbol. It is not necessary to reproduce texts carrying this symbol.
<u>NOC</u>	Proposal for ITRs text to be maintained without change NOTE – This symbol may be used together with a proposal number when Member States wish to emphasize that a particular provision or provisions of an article should remain unchanged, e.g. Article XX may be shown as NOC but provisions AA and BB of Article XX may be shown as <u>NOC</u> . The reasons as to why these provisions <u>need to be</u> maintained without change should be given.
OTHER	

- ABC: is the Source (code of the Member State(s) author(s) of the proposal(s))
- 25: is the document number assigned by the Secretariat in which the proposal is published.
- 3: is the number of the proposal within that document.
